MOTION TO COMPEL THE INDIANA DEPARTMENT OF WORKFORCE DEVELOPMENT, A NON-PARTY, TO DISCLOSE CONFIDENTIAL INFORMATION

Plaintiff requests that the Court order the Indiana Department of Workforce Development (IDWD) to provide Defendant’s last known employer information to Plaintiff. Plaintiff needs the requested information to attempt to collect the judgment through an order to garnish Defendant’s wages.

In support of this motion, Plaintiff states:

1. Plaintiff owns the judgment rendered in this cause against Defendant.
2. Plaintiff’s judgment is unsatisfied.
3. If Plaintiff and Defendant entered into an Agreed Judgment, Defendant has not made payments as ordered by the Court.
4. The IDWD requires requests for information, including Defendant’s last known employer, to include a scanned copy of a court order requiring the IDWD to disclose this confidential information.
5. Plaintiff has complied with the requirements of Indiana Trial Rule 34(C) by providing a copy of this motion to all parties at least fifteen (15) days prior to submitting this motion to the Court. The notice was sent by first-class U.S. mail to Defendant’s last known address on _____ (date).

Plaintiff, therefore, requests that the Court order the IDWD to provide Plaintiff with Defendant’s last known employer information.
